Some highlights from 2025:

- Following the work and recommendations of the Vandersall Group in November of 2024, three working groups were organized to research these options.
  - ◊ Housing Development Team (Led by Peter Benner)
    - ◆ Researching the repurposing and/or selling all or part of our building/grounds to achieve missions supported by Westminster.
  - ◊ Rental Partner Team (Led by Steve Frazzini & Greg Hammond)
    - ◆ Researching ways to generate income needed to support our property.
- Partnership with First Presbyterian Church of Hartford (Led by Janet Wade-Utay)
  - ◊ Researching the possibility of combining congregations, resources and/or buildings with First Presbyterian Church of Hartford.
- During the months of July and August, our congregation met jointly with First Presbyterian Church of Hartford. In July, we worshipped at First Presbyterian Church and in August, members of First Presbyterian joined us in West Hartford for worship.
- Staff were furloughed for the month of July and the building was mostly closed during July.
- Session approved fund raising as part of the celebration of Westminster's 75th anniversary. It approved that 20% of money raised would go to support the Serve team's activities.
- The session approved a budget for 2026 which includes a deficit (will be covered by loan from endowment) and which includes creating a new position to oversee rentals of the building.
- We have seen a slight increase in overall attendance from 2024 (62.3 compared to 59) and net gain of 3 members.

*“O sing to the Lord a new song, for God has done marvelous things!” Psalm 98:1*

The year 2025 marked the seventy-fifth year of ministry for Westminster Presbyterian Church, inviting us to celebrate all of the marvelous things that God has done in our community throughout the years. As we celebrated our history, we also found ourselves looking forward and imagining what God might be doing with us in the current age. These two actions, looking to our history and imagining our future, developed into our 75th anniversary theme: Deep Roots & High Hopes.

We explored our Deep Roots in various ways throughout the year. We shared stories from the earliest days of Westminster, the small group of faithful members of the First Presbyterian Church of Hartford who were commissioned to start a church in West Hartford in 1950. We celebrated the continued connection with our sibling church downtown and joined our congregations for summer worship for the second time.

We shared the story of our congregation’s relationship to the property where our church currently stands: How Westminster began as an itinerant group of worshippers, gathering in different places around West Hartford. And then the efforts the early congregation took to secure funds, attain zoning approvals, and make the Pitkin House ready for worship, and then the development of our current building, all of which help us appreciate the gift that has been entrusted to us in this place and space.

We honored our continued love and appreciation of music, taking the opportunity on our annual Music Sunday to celebrate our history as well as to commission a brand new piece of music for our choir, written by one of our Choral Scholars, Zac Burns. While the way we share music has evolved over the years, we continue to strengthen a vibrant and joyful music ministry which uplifts and sustains our worship.

As we prepared for a more robust season of celebration in the fall, we reaffirmed our congregation’s commitment to justice and care for our neighbor. We set a fundraising goal and chose, even in a season when our finances are challenging as a church, to set aside 20% of the funds raised for mission and service. Recognizing the ways our community has changed, we invited former members and pastors back to celebrate with us, hosting a worship service and luncheon.

Joyfully, we reaffirmed our commitment to be a place of welcome and inclusivity for all people. A profound moment in our celebration was the reading of a letter from the Presbytery of Southern New England which acknowledged the struggles Westminster leaders and pastors went through in the late 1990’s to stand up for our LGBTQ siblings in faith, even when that fight caused a rift between our church and the Presbytery. The Presbytery noted our early advocacy and role as a “trailblazing congregation” in the movement for justice and inclusivity, despite the consequences, and named our prophetic ministry as a testament to our faith in the God of Justice and Peace. All who were present felt the impact of those words as an important step in reconciliation and renewal.

Grounded in deep gratitude of our history, we continue to have high hopes for our future. We welcomed eleven new members in 2025, each a gift to our community and bringing with them enthusiasm and new gifts to share. We continue to ask profound questions about the best and most faithful use for our property, seeking to be good stewards of the gifts that God has given us through those who came before us.

We continue to care deeply for our neighbors in need, working for justice through our relationship with the Greater Hartford Interfaith Action Alliance, as well as strengthening our partnerships with organizations who serve and support those who are struggling with food and housing insecurity.

We continue to be a place of welcome and community support, strengthening our connection with a variety of organizations who use our building. On any given week our building is filled with beautiful music, the laughter of multiple bustling Scout troops, diverse cultural gatherings, a retired men's philanthropic group, writing classes and all manner of support groups. We are grateful for our deepening relationship with the West Hartford YMCA, and look forward to how that relationship might grow in the future.

Despite the division and strife that seem to be plaguing our country, despite the challenges we face in our increasingly secular world, we continue to share a sense of hopefulness and connection in this place. While our celebratory year has concluded, with deep roots and high hopes, Westminster continues to faithfully follow where God is leading us, sharing the love and justice of Christ with our community and world.

## **75th Anniversary Celebration** **Linda Geisler and Barbara Riihimaki, Co-Chairs**

2025 marked the 75<sup>th</sup> anniversary of Westminster Presbyterian Church. This special milestone was celebrated in myriad ways throughout the year, culminating in Celebration 75 - Worship Service and Luncheon on All Saints Sunday, November 2, 2025.

### **WPC History Articles in Weekly Newsletter (May/June & Oct/Nov)**

Rev. Julie Emery wrote a series of articles in the weekly email newsletter chronicling some of the stories of Westminster's beginnings. Later in October, Becky Kimberly compiled the writings of Westminster's first historian, Mrs. Alice Evans Dannreuther, and shared them with the congregation by email in the week leading up to Celebration 75 Sunday Worship and Luncheon.

### **Commissioned Music – “Pray”**

The Westminster Choir debuted a specially commissioned composition on Music Appreciation Sunday, May 18, 2025, in honor of the congregation's 75<sup>th</sup> year of worship and music. “Pray,” composed by Tilton Scholar Zac Burns with lyrics by Minister of Music Callie Boone, was inspired by Westminster's journey from its founding and into the future. The choral work is described as a conversation both with God and within our church community, expressing a commitment to our core values of deepening faith, building relationships, and pursuing justice.

### **Boulevard Music Fest**

The Tilton Music Scholar's fundraiser was held on Saturday, October 18, 2025. In celebration of the anniversary, free cupcakes were offered at the Westminster booth for anyone who signed our giant anniversary card. Visitors could also get their picture taken (with or without costumes/props) in front of the Celebration 75 banner or by a fall-themed scene of potted mums and a bale of hay.

### **75<sup>th</sup> Anniversary Fund**

Session approved a limited-time fundraiser in honor of the anniversary which would give 20% of funds raised to Westminster mission partners allocated by the Serve Team. The remainder went into the endowment. A goal of \$75,000 was set and a small group of donors committed to matching gifts up to \$25,000. Current and former members were invited to contribute. At last count, 46 donors contributed over \$53,000. A formal thank you letter from the Co-Chairs was included in a notecard with a handwritten note to people who contributed to the 75<sup>th</sup> Anniversary Fund. Each donor also received a glass ornament with the 75<sup>th</sup> Anniversary logo printed on it.

### **Historical Donations, Pop-Up Museum & Scavenger Hunt**

Donations made to the church over the last 75 years were gathered (some unearthed from depths of closets) and their stories researched and documented by Barbara Riihimaki. A document was created entitled, “Westminster Presbyterian Church ~ Historical Donations” to capture the details of the donated items and with the hope that it can be updated as other donations are received in the future. Didactic labels were created for each piece and posted with the item for members to explore at their leisure. Portable items were displayed in the Covenant Room and other items remained where they are still used throughout the church as a temporary “Pop-Up Museum”. A scavenger hunt was created for a fun and interactive experience. The Pop-Up Museum and Scavenger Hunt opened on October 26, 2025.

### **Bulletin Boards**

- **Photo Walls Bulletin Boards:** Photos from the archives were labeled and displayed into 25-year increments (1950-1975, 1976-2000, 2001-2025) on the bulletin boards in the hallway wall closest to the sanctuary outside of the office.
- **Serve Team Bulletin Boards:** In anticipation of Celebration 75 Sunday, the Serve Team updated the bulletin boards with meaningful information about the organizations Westminster supports and the work that they do. Two boards were created. One displayed the service organizations we work with, their logo and a brief description of their mission. The other elaborated on GHIAA (Greater Hartford Interfaith Action Alliance): its history, accomplishments, and goals. These bulletin boards serve to educate our members and visitors on how we act on the core values of the church.

### 1950-2025 Timeline

A giant 35.5' long interactive timeline was created to highlight significant events in the history of the church for each year since its 1950 inception. Important world and country events were also separately noted. And space was reserved for parishioners to add significant memories and photos of their life at Westminster. The timeline was erected along the education wing hall across from the bathrooms in time for the Nov. 2 celebration and remained hanging until the end of 2025.

### Memorabilia Table Display

A sampling of directories over the past seven and a half decades were displayed for folks to peruse and marvel over all the changes in the property, building, clothing and hair styles. Commemorative plaques, old bulletins, and a binder of notes received in recognition of this important milestone were also included on the Memorabilia Table which will remain on display through February 2026.

### Labyrinth Restoration & History

The labyrinth on the lawn outside of the Fellowship Hall, which was originally built as an Eagle Scout project by Westminster member Adam Bender, was cleaned up and restored for the 75<sup>th</sup> anniversary festivities. Wanda and Dan Bender created a booklet documenting its history that was on display during the events.

### Celebration Sunday Worship Service & Luncheon

Westminster's 75<sup>th</sup> anniversary was commemorated on All Saints Sunday, November 2, 2025, with a special worship service and luncheon. Former members and clergy joined current congregants with over 100 people in attendance. Rev. Julie Emery was joined in leading worship by former head of staff Rev. Graham Robinson, Rev. John Merz, and Rev. Jinny Smanik. Music included hymns that were sung at the inaugural service in 1950. Barbara Riihimaki offered the Moment for Generosity highlighting the special displays and the 75<sup>th</sup> Anniversary Fund.

A highlight of the service were messages delivered from the pulpit by Mildred McNeill, Co-Moderator of Roundtable for the Presbytery of Southern New England (PSNE) and a member of First Presbyterian Church of Hartford. Mildred read messages of congratulations from both communities, recognizing Westminster Presbyterian Church as a leader of justice and inclusion for all God's children. These letters will be framed and hung in the Covenant Room.

Desserts featured a sheet cake from Costco and an allergy friendly "Amazon Cake" from the cookbook. The cakes were cut by the two earliest Westminster members in attendance, Dick Stafford and Lynn Wadhams.

During the reception, Julie Emery welcomed guests and offered personal reflections. Barbara Riihimaki acknowledged everyone who worked on the anniversary celebrations. Linda Geisler read notes received by clergy associated with Westminster who were not present: Rev. Ann Beams (Interim Pastor, 1998), Rev. Susan Power Trucksess (Interim Pastor, 1998), Rev. Dr. Charlie Berthoud (Baptized, 1964; confirmed, 1979; ordained 1991), Rev. gretchen Sausville (Associate Pastor, 2007-2017). Then clergy in attendance were invited to offer reflections followed by several congregants in attendance.

### **New Member Class**

A group of 11 new members were received on November 9, 2025, the week following Westminster's Celebration 75. Initial thoughts to receive new members during the anniversary celebration worship service were changed to keep the Celebration 75 worship service to a reasonable time limit. In the end, receiving new members the week after All Saints Day when we remembered the members who passed during the previous year had a nice symbolic balance.

### **History of Westminster Church**

Elder Karen Wagner's summary of Westminster's history as gleaned from the minutes of Session meetings and committee reports from 2001-2025 will be added to the current summary of history from 1950-2000. This document will be made available to members and will be given to new member class participants in the future.

### **Communications, Promotion & Logos**

#### **75<sup>th</sup> Anniversary Artwork**

- Callie Boone created a work of digital art specifically for the bulletin cover on Music Appreciation Sunday in May 2025. It was a beautiful layering of a photo of one of the church's quilts, musical notes, a pen and ink rendering of the church building (previously used as a logo), the current logo and a large "75" in the lower right corner (*see image to the right*).
- The special graphic was used throughout the 75<sup>th</sup> celebrations: It was printed on a 6'x6' fabric banner and used as decoration at Boulevard Music Fest and in the sanctuary on Celebration 75 Sunday; it was used on the cover of the bulletin again for Celebration 75 Sunday; it was used on the Thank You notes for those who donated to the anniversary fund.



- **75<sup>th</sup> Anniversary Mailing**

A letter from the committee co-chairs was mailed to current members, a curated list of former members, and to former clergy and staff inviting them to join in the Celebration 75 activities.

- **75<sup>th</sup> Anniversary Logo**

A special version of the Westminster logo was created incorporating the years and important guiding tenants of our congregation-faith, community & justice (*see cover of the annual report*).

- **Promotion**

Regular announcements in the weekly newsletter, lawn signs on the perimeter of the church property and Moments of Generosity were used to promote awareness of the anniversary and events.

## Callie Boone Minister of Music

Psalm 133:1 *How wonderful it is, how pleasant, for God's people to live together in harmony!*

In 2025, the focus of the Music Ministry shifted from asking “What brings you joy?” at the end of June to “Noticing the joy of being together” in September. Inspired by Psalm 133:1, we committed ourselves to reflecting upon how we, as a music family, can be an example of the power of community both in and outside of the church. Our intention was (and will continue to be in the first half of 2026) expanding the reach of the Music Ministry by Growing with Grace.

Our first goal is to **empower** through invitation. With all ages, stages, and abilities welcome, we have our attention on welcoming any and all who would like to take part in any music group, in any capacity. The result has been an increase in our Chancel Choir members, a refresh in our Handbell Choir members, the addition of three new A/V technicians to our roster, and the largest Christmas Eve Choir since the beginning of the initiative in 2022.

We also had the gift of Danielle O’Neil shifting from choir member to Organist/Accompanist in January 2025. This transition has been an embodiment of **love**, the second vehicle for growth with grace. Love, in this way, is driven by the work of meeting ourselves where we are, knowing that is exactly where we need to be. As such, when Dani started, she was filling an interim position and did not know how to play the organ. With months of dedication and diligence, Dani has not only become an incredible organist, but she has also transitioned into a permanent role as of December 2025. She gives freely of her time, talents, and encouragement as a constant reminder of what is possible with faith and leaning into the love of our music community to foster personal growth. Her presence in our midst is truly a blessing.

And finally, with the broader community in mind, we have worked to **expand** through generating connections with musical groups outside of the church. This created opportunities to

- Collaborate with First Presbyterian Church of Hartford over the summer
- Commission a choral piece by Zac Burns, Tilton Scholar, for Music Appreciation Sunday in celebration of our 75th anniversary
- Offer multiple, successful fundraiser concerts for the Tilton Scholars (Community in Concert featuring the Lillibridge Ensemble, International Music Festival, Boulevard Music Festival, Taige Wang in concert)
- Install updated A/V equipment in the Fellowship Hall, funded by the generosity of the Old Guard, supported by CMI Sound Systems, and utilized for several church and rental group events
- Receive the gift of handcrafted storage for equipment behind the Chancel and for rhythm instruments in the Choir Room from Jacob LaPointe, Eagle Scout
- Enjoy special music in worship (Han Hu, Jenifer Combs, Katalin Vizsmeg, Elliott Davis, Talcott Singers, Thread City Brass, Concora musicians)
- Generate performance opportunities for groups in our space (Friendship Service Center Benefit Concert, Simsbury High School Tri-M Coffee House, Heather Tusch Recital)
- Welcome back regular rental groups like VP Vocal Studio and the Hartford Musical Club, who continue to be incredibly supportive of our ministry through the use of our space.

It is with deep gratitude that the threads of joy and connection have spurred us towards such growth in 2025. I am thrilled to bear witness to the continuation of this work for our music family in 2026.

Thanks to the amazing creativity of our staff with support from the Worship Team, we continued to offer meaningful hybrid worship experiences throughout the year. In addition to Sunday services, Rev. Julie Emery was available throughout the day of Ash Wednesday to share reflections and offer ashes. During Holy Week, First Presbyterian Church of Hartford (FPCH) joined us on Maundy Thursday for a shared service and meal. On Good Friday, Rev. Julie Emery led a Taize service of readings and hymns at noon.

We worshiped jointly with FPCH during the months of July and August. FPCH hosted worship in July and Westminster hosted worship in August. The combined worship was well received by both congregations and gave us a chance to experience the connectional nature of being Presbyterian. All services were offered in a hybrid format throughout the summer.

In May, we said farewell to Elaine Song, who had been with us since September 2024 as our Yale Divinity School intern.

At a special service on November 2, we celebrated the 75<sup>th</sup> anniversary of Westminster's founding. Former members and ministers were present for the service and the luncheon that followed. We are so grateful for the hundreds of hours of work by dedicated members who made that day so special.

On December 21, the fourth Sunday in Advent, we celebrated the Paper Bag Pageant in our morning service to recall the Christmas Story of Christ's birth. That evening, we hosted an interfaith Longest Night service to bring comfort and community to those for whom the holidays are difficult. Greetings from the world of Faith Formation at Westminster! If these greetings were being sent as a postcard or letter, it would collect many postmarks. Faith Formation is something that is a part of all areas of our church life. You will find Faith Formation (for all ages) happening during Sunday morning worship services, at fellowship events, while we are serving our neighbors, and in many other places. Below are just a few of the places where Faith Formation has been active in 2025:

- Each Sunday morning our Sanctuary houses stations that are set up to be an active way to participate in worship. ## Serve Team Lesley Morrey, Elder

*The Serve Team is the “mission arm” of our church, engaging in charity, mission, and pursuing justice locally and beyond.*

Westminster supports a variety of local non-profit charitable organizations, many of which have had a relationship with our congregation for many years. As part of the 75th anniversary celebration, a compelling bulletin board was created outside the Fellowship Hall highlighting the missions of each organization we support to further reinforce this connection.

These deserving organizations received financial assistance in 2025: Foodshare, Integrated Refugee and Immigrant Services (IRIS), My Sister’s Place, Prudence Crandall Center for Women, Habitat for Humanity, Hillcrest Area Neighborhood Outreach Center (HANOC), Hands on Hartford, Hour of Giving for Presbyterian Ministries, and More Light Presbyterians.

Westminster also embraces organizations with our collective time and talent plus funding. Here’s a snapshot of these activities:

**Greater Hartford Interfaith Action Alliance (GHIAA):** In addition to our financial support of this impactful regional organization, Westminster was a host site for a GHIAA House Meeting in November on the subject of housing affordability.

**Covenant to Care:** Augmenting our twice annual financial assistance in the form of gift cards for client needs, Westminster supported Department of Children and Families social worker Nadia Pelaez with three special collections:

- **Back to School** - 18(!) back packs filled with age-appropriate school supplies (Value \$1800)
- **Thanksgiving** - 10 baskets of non perishable holiday foods including \$50 gift cards per basket to Walmart
- **Perishable food** or other needed items (Value \$1000)
- **Christmas** - Gifts for 11 children plus \$250 in gift cards (Value \$800)



**Jessie’s Garden:** The garden located on the corner of Ridgewood and Boulevard grows organic produce - tomatoes, eggplant, peppers, squash, beans, and herbs. During the harvest season, vegetables are delivered to Loaves and Fishes one to two times a week. Loaves and Fishes serves lunch and dinner five days a week to the food insecure. Westminster also supports the Loaves and Fishes mission with a financial donation.

**South Park Inn:** Complementing our financial support, church members cooked, delivered, and served a hot meal once per month to South Park Inn clients. In January 2025, Westminster members also donated several shopping bags of winter necessities (toiletries, socks, hats, gloves, hoodies, long underwear etc.).

**West Hartford Food Pantry:** We continue to accept and deliver donations of nonperishable foods to this local food bank. The Serve team started in Fall 2025 a routine effort to promote food collection on Communion Sundays, which has proven very successful in increasing food donations. Food is also collected at special events such as the Community Easter Egg Hunt.

**Troops 163 and 1163:** Beyond the support of the troops with meeting and storage space, five Scouts were gifted a \$25 gift card in celebration of achieving the rank of Eagle Scout, including the first female Eagle Scout from Troop 1163.

In support of our wider community, in June, Westminster joined our sister congregation First Presbyterian of Hartford on a service and learning trip to La Casona de Monteflores in San Juan, Puerto Rico. Volunteers cleaned, conducted grounds maintenance, and reorganized Proyectos Alegria, a local social services agency. The trip was under the auspices of Presbyterian Disaster Assistance.

The church also supports many local non profit organizations with space either for low cost or no cost, including Al-Anon, AA, National Alliance on Mental Illness (NAMI), Overeaters Anonymous, and Families Anonymous.

The total of Westminster's financial support for community-based organizations was \$12,642.44, not including special collections direct from members, donations specifically earmarked for the Puerto Rico Mission Trip, or in kind donations.

## **Westminster Mental Health Community Hub**

The Westminster Mental Health Community Hub Task Force consists of Peter Benner, Larry Carr, Julie Emery, Molly Gavin, Merrill Hoelzel, Cindy Buckley, Laura Opsahl, Diane Smith, Janet Wade-Utay, Tom Buckley

The Westminster Mental Health Community Hub Mission Statement:

***Westminster Presbyterian Church's Mental Health Hub works to connect youth, families, and the community to resources, guidance, and a safe space to explore, learn and discuss mental health concerns.***

The Hub Task Force delineated how best to use the grants received specifically for the development of the community hub, primarily focusing on mental health. Programming options were formulated into three categories: (1) education/awareness presentations to a large, community audience; (2) trainings on specific topics for smaller audiences; (3) certification programs that may require pre-work and in-person training.

We had two community presentations in 2025, and both were author presentations discussing their book with book signings. On June 29 we presented *Weathering the Storm: Simple Strategies for Being Peaceful and Prepared*, featuring author and chaplain Rev. Dr. Tracy Mehr-Muska. On October 14 we partnered with the Farmington Valley chapter of NAMI-CT to present *ReConnect: A new framework for helping parents protect their child from anxiety and depression fueled by digital addiction*, with the co-authors Personality Type expert Paul Tieger and psychologist Michael Shelby. Both programs were very well-received and had a total of 88 attendees.

The Community Hub submitted four grant applications in 2025, unfortunately only one proposal was accepted and funded. The following three grant proposals were not accepted: the West Hartford Community Development Block Grant (\$220,000), the West Hartford Greater Together Community Fund (\$10,000), and the Creative Ministries Offering Committee of Presbyterian Women (\$149,407).

Thanks to the work of Diane Smith, we did have our application for the West Hartford Prevention Council accepted for \$5,000. The grant project title is: *Addressing Root Causes and Solutions: The Science and Psychology of Opioid Misuse and Prevention*. The project will implement a two-part educational series focused on the science, psychology, and the role that Adverse Childhood Experiences play and link to substance misuse, including opioid dependency. The goal is to provide parents, caregivers, and youth-serving community volunteers/mentors in West Hartford with the knowledge and tools to identify the impacts of trauma and actively build resilience in youth.

The Hub Task Force continues in conversation to strengthen our partnership with Beth El Temple as they explore and develop a potential Clubhouse International site at Westminster.

Phone calls, notes, visits, meals and childcare are coordinated as needed. We are especially grateful for the ministry of Rev. Laura Opsahl and Elder Nicole Aronson who spend many hours visiting our @Home Worshippers.



Before Easter, spring flowers were delivered to our @Home Worshippers. And at Christmastime, the Care Team invited the congregation to help assemble gifts of potpourri jars which were then delivered to these friends (*see photos above*).

### **Prayer Shawl Ministry**

During the winter and spring, crafters met monthly to tie and knit together in community. Westminster's prayer shawl and blankets monthly gatherings were on hiatus during the Fall of 2025 due to anniversary and other activities. Four shawls were given to friends in need this year.



### **Memorial & Meditation Garden**

The Memorial and Meditation Garden was dedicated in 1986 and continues to be a resting place for the ashes of our members and friends. The location and landscaping provide a special place for reflection and thanksgiving for the lives of those remembered.

This past year, Elsie Harp (July 25, 2025), joined other members and friends in the Garden. ### Building and Grounds Committee Steve Frazzini, Elder

The Building and Grounds Committee consists of Steve Frazzini, Chair, and Alan Zapata and John Rhine. Our Sexton is Mike McElroy.

We always welcome additional members to the team so if you are handy or just want to help preserve our beautiful facility, please contact one of our team members and we would welcome your assistance. Since the team is responsible for the stewardship of all of our buildings and over 2 ½ acres of lawn and gardens, there is always something that requires attention. The past year was no exception. We had grounds clean-up in the spring and fall. Last year we also tried to address problems with the steam pipes, and that was ongoing

One recurring B & G task was to deal with the sanctuary fan that was damaged by a balloon and string brought into the sanctuary during a rental event by a child. The fan simply stopped working. Our Minister of Music told us that the working fans were important for long-term preservation of the organ and we thus decided we could not leave the fan in disrepair. An electrician verified that the problem wasn't with the controller unit, and the plan initially was to replace the fan. After one company backed out partially through the process, we finally got to the day to install a new fan, which had to be ordered. It was also going to need to be painted in order to try to match the other two sanctuary fans. Installation would be a two-day project, the first for the electrician to bring in equipment to enable up-close inspection of the fan. Not having the equipment ourselves to get high enough for a close inspection of the fan, we were still hoping that possibly the broken fan could be fixed. After inspection, the plan was to paint the replacement fan, wait overnight for the paint to dry, and install it the second day. During inspection on the first day the electrician found remnants of the balloon and string inside the fan, and removing them enabled the fan to work again. No new fan needed!

The second B&G task has been to work with the rental work group created by Session to explore possible new sources of income. Session formed a second team to work on exploring possible development for much-needed affordable housing. *Please see reports on page 22 for more information.*

## **Rental Work Group Steve Fazzini, Chair**

The work group has met virtually during the fall and early winter.

Two possible new rental partnerships were explored last year:

One was Sunday use of the Fireside Circle by another worshipping community, but that possibility did not come to fruition after discussion between the two groups. The second possibility was to explore again using the building and grounds for a YMCA summer day camp. That had been discussed between the two organizations in 2024 but those discussions never progressed beyond that. This year, a new chief executive officer for the YMCA of Greater Hartford expressed his desire to partner with WPC as part of the Y's return to a West Hartford presence.

There were numerous meetings and walk-throughs with the Y and by the end of the fall the church had a working agreement with the Y on how to proceed. In December we met with town zoning officials. By year's end, the church had submitted an application for a Supplemental Use Permit that would be considered by the town's Planning and Zoning Commission in 2026. We are grateful to the many members of our church community who worked very hard on this project.

## **Housing Development Team Peter Benner and Will Hoelzel, Co-Chairs**

As part of our discernment process initiated in 2024, the Session created a Housing Development Team to explore the potential options and feasibility of developing much-needed affordable housing to add to Westminster's mission. The team was active and met regularly throughout 2025, conducting background research and consulting experts in the field.

In the fall, we became aware of the opportunity and applied for a grant from the Housing Ministries of New England. The grant would enable the hiring of a housing consultant and an architect, who could perform a detailed assessment, identify options and evaluate feasibility for the team. These results would then be used to make an informed report to the Session and the congregation. The application was accepted and Westminster was awarded the \$25,000 grant. In January 2026, the Housing Team hired a consultant and architect whose work will be entirely funded by the grant. They will present a report that will propose ways Westminster's facility could be used for housing projects. This feasibility study, which should be completed by June 2026, is for informational purposes only to be used in our discernment process moving forward.

## **Ministerial Relations and Personnel (MR&P)** **Janet Wade-Utay, Chair**

Committee: Janet Wade-Utay, Chair, Molly Gavin, Steve Fazinni, and Rev. Julie Emery

The MR&P Team functions as the human resources arm of the Session, advising it on the care, supervision, and compensation of all church employees.

Highlights from our work in 2025 include:

- **We welcomed Danielle O’Neil as our interim accompanist.** Danielle did an amazing job accompanying the choir and soloists, presenting worshipful and beautiful special music during worship. In December we were pleased to offer Danielle the position as permanent accompanist which she accepted.
- **Employee benefits/ Health Plan Offering** – MR&P continued to look at employee benefits offered both by the Presbyterian Board of Pensions (BOP) and through Advanced Benefit Strategies to offer the best possible benefits to our staff. The added benefits through Advanced Benefit Strategies for staff members were continued in 2025 with the exception of the ICHRA eligible to employees who purchase health insurance on the open exchange and the Westminster match for the retirement savings plan..
- **Board of Pensions Pastoral Benefits** – The medical insurance premiums continue to increase for the pastor benefits plan within the Board of Pensions.
- **After evaluating the benefits and challenges** of the staff furloughs and other cost reductions, MR&P decided to eliminate the furlough for 2026 and recommend a 3% cost of living for staff.
- **MR&P prepared the staff budget** and proposed Pastor Terms of Call. The MR&P budget for 2026 is a budget for growth that includes a new part-time staff position that will support and build on current relationships with organizations renting space at the church. It will also promote and develop new relationships to increase the rental revenue. The new position will consolidate the many tasks of managing and hosting renters at Westminster, freeing up time, focus and energy currently being performed by other staff members rather than supporting Westminster's ministries.

The MR&P Team is deeply appreciative of all our staff members, their gifts, talents, and commitment to Westminster are inspiring. We are thankful for the continued support of the congregation for the staff and programs at Westminster.

**Minutes of the Annual Meeting of the Congregation  
Westminster Presbyterian Church  
February 23, 2025**

Moderator Julie Emery called the meeting to order at 11:30 am with an opening prayer.

Moderator Emery declared that there was a quorum of at least 25. Actual attendance was 39, including online participants. The moderator read the call for the meeting. Notice had been given on at least two preceding Sundays.

The congregation **VOTED** to approve the agenda.

The congregation **VOTED** to approve the consensus motion, including receiving the minutes of the Annual Meeting of the Congregation of February 25, 2024; the minutes of the Congregational Meeting of June 23, 2024; the statistical report of the membership; the Pastor Report from Rev. Julie Emery; and the Clerk of Session Reports.

Appearing on video, Greg Hammond, on behalf of the finance team, gave an overview of 2024 Year End Financials and the 2025 Operating Budget. He pointed out that the Finance Committee had reduced the operating deficit to less than \$100K.

It was **MOVED, SECONDED, and VOTED** to receive the 2025 budget.

Moderator Emery presented a PowerPoint on the report of the Vandersall Collective, which PSNE Trustees had hired last summer. The consultants' charge was (1) to help PSNE develop a theology of land and property; and (2) to work with Westminster, First Presbyterian Church of Hartford, and MLK Jr. Community Presbyterian Church of Springfield to see what might be possible with their property.

Moderator Emery presented the Vandersall consultants' work with Westminster.

- They reviewed the five focus areas of the Session and expressed some concerns about the ability to succeed as currently presented and then presented alternatives aligned with their charge from the PSNE trustees.
- Increase the use of the building significantly to generate revenues that offset building costs.
- Sell/ develop the property for alternative use such as affordable housing
- Explore partnerships with First Presbyterian Church Hartford and Martin Luther King Community Presbyterian Church in Springfield to understand how our ministries could flourish with closer collaboration.

The Chair of the Ministerial Relations and Personnel Committee, Janet Wade-Utay, for the Session, presented the Pastor/Head of Staff's terms of call for 2025.

It was **MOVED, SECONDED, and VOTED** by a secret ballot with 30 in favor and none against. In-person and on-line members cast their votes. Due to the length of the meeting, nine people left before the terms of call were discussed.

## **Finance Committee Report For Year Ended December 31, 2025**

The Finance Committee is responsible for overseeing the financial functions of the church with the various members responsible for different functions including bookkeeping, financial reporting and controls, treasury functions and development of the annual budget. The members of the committee included Liz Doering, Julie Emery (Pastor), Steve Frazzini, Greg Hammond (Chair), Glenn Johnson, Alyssa Mansolf, Kevin Morrison (Treasurer), Eric Ouellette (Bookkeeper), and Janet Wade-Utay.

Our Endowment Funds and some restricted funds are invested with Charles Schwab and New Covenant Trust Company. For 2025, Liz Doering, Steve Frazzini, and Eric Ouellette are signers on the Schwab Funds and Kevin Morrison and Eric Ouellette are signers on the New Covenant Funds. The Finance Team manages the investments, and the Endowment Committee is responsible for overseeing the funds.

We would like to take this opportunity to thank our counters who work in teams to ensure all contributions are recorded properly and deposited weekly: Eliza Cleaveland, Abbey Downing, Liz Doering (team leader), Steve Frazzini, Sandy Fry, Sheila Huddleston, Jean Summers, and Rick Thibodeau.

We would also like to thank Westminster's bookkeeper, Eric Ouellette, for the care, grace, and patience he brings to maintaining our financial records. We greatly appreciate Eric's ongoing contributions and support.

In 2025, the Finance Team worked with Eric to revamp Westminster's chart of accounts to better facilitate the ability to produce the monthly financial statements directly from QuickBooks. The Finance Team also revised the expense voucher and created written procedures for submitting disbursement and reimbursement requests.

### **FINANCIAL OVERVIEW FOR 2025**

#### **Statement of Financial Activity**

The 2025 financial results reflect a year of both faithful support and real financial pressure. Westminster Presbyterian Church concluded the year with a **Net Operating Deficit of \$83,982**, underscoring the gap between recurring operating income and the true cost of sustaining our ministries, staff, and facilities.

**Total Operating Receipts of \$376,286** consisted primarily of **\$265,958 in Pledged Contributions**. While meaningful, this amount was below both the prior year and budget expectations. The decline reflects natural membership transitions, including households relocating and the loss of several long-standing members, whose faithful support has meant so much to Westminster over the years.

Building Use continued to be a significant and encouraging source of income at **\$50,036**, exceeding the budget and demonstrating the value of expanded use of our facilities. Special gifts and grants, including **\$38,000 in special gifts** and a **\$10,000 grant** from the Roosa Foundation, also provided important support for Westminster's ministries.

To support core operations, the church relied on **\$70,793 in fund transfers** from endowment and restricted funds. While these transfers were within approved policy and donor intent, they highlight the extent to which operating needs continue to exceed operating income. **Total Operating Income, including transfers, was \$447,079**, which was only \$173 below the budgeted amount for 2025 but remained insufficient to fully cover expenses.

**Total Disbursements were \$531,061**, driven largely by **staff expenses of \$340,831** and **church building costs of \$113,807**. These costs represent largely fixed investments in the people, programs, and facilities that sustain Westminster's ministries.

During the year, several one-time infrastructure needs also contributed to expenses exceeding budget, including much-needed upgrades to staff computers and equipment and timely parking lot repairs completed at a reduced cost for materials only. While not fully anticipated, these improvements were prudent investments that support safe and effective operations and help prevent larger costs in the future.

During 2025, Session implemented several temporary cost-saving measures in an effort to reduce operating expenses. Building on our summer worship partnership with First Presbyterian Church in Hartford, the church building was closed for the month of July, which lowered utility usage and allowed for two weeks of furlough for the Church Administrator and Sexton, with the remaining time covered by scheduled vacation. The Director of Faith Formation position was reduced from twelve months to ten months, and a portion of increased medical and healthcare costs for the pastor and her family was shifted to the pastor.

While these steps were projected to save approximately \$25,000, not all anticipated savings were realized. In addition, reduced staff presence and building availability during the summer affected ministry activities and contributed to some lost rental income. These experiences provided valuable insight as we continue working to balance careful cost management with sustaining the level of staffing, building use, and ministry engagement that our congregation expects.

Staff expenses exceeded the budget primarily due to two factors. First, due to an administrative oversight, matching 403(b) contributions continued for the first ten months of the year before being discontinued as planned. Once identified, the match was promptly stopped. Second, higher-than-anticipated healthcare costs for the pastor and her family contributed to the variance. Together, these items account for most of the increase in staff-related expenses.

It is important to note that the operating deficit was partially offset at the total church level by **strong non-operating results**. Restricted funds generated **net positive activity of \$61,054**, and **investment performance contributed \$96,440** in net investment income. As a result, the church ended the year with **Net Revenue of \$73,512**, reinforcing Westminster's overall financial stability despite operating challenges.

### **Statement of Financial Position**

Westminster's overall financial position at the close of 2025 reflects both the realities of operating with a deficit and the strength of the church's long-term assets, disciplined oversight, and thoughtful planning for the future.

In 2024, the Finance Team recommended and the Session approved a **\$150,000 internal loan from the Endowment funds** to support ongoing operating needs while the church works through a period of structural deficits. Because the loan is internal, there is no interest or set repayment schedule, though it remains the clear intention that these funds will be repaid to the Endowment as future financial stability allows.

Recognizing that sustainable solutions require more than short-term adjustments, Session launched **three work groups during 2025** to explore longer-term opportunities. These groups are focused on expanding rental and building use, evaluating the potential use or sale of portions of the property for affordable housing, and exploring deeper partnership opportunities with First Presbyterian Church in Hartford. While these initiatives will take time to develop, they are intended to strengthen recurring revenue, reduce financial pressure, and create a clearer path toward repaying the Endowment loan. Depending on timing and implementation, additional temporary borrowing may be needed as the church invests in these future-oriented strategies.

Despite transfers from Endowment and restricted funds to support operations, **investment performance during the year exceeded these withdrawals**, resulting in an overall increase in total assets. This strong investment performance continues to provide important stability and flexibility for Westminster's long-term ministry.

The church also celebrated its **75th anniversary in 2025**, which became both a time of gratitude and generosity. After expenses, the anniversary efforts generated **\$48,221 in net contributions**. In keeping with a forward-looking spirit, Session designated **80% to the Endowment Fund** to strengthen Westminster's future and **20% to the Westminster Fund for Mission** to support local community organizations. As of year-end, the Westminster Fund for Mission held a balance of **\$9,644**, enabling continued outreach beyond our walls.

In summary, 2025 was a year that required careful stewardship, honest assessment, and thoughtful adjustments. While operating income did not fully meet expenses, Westminster continues to benefit from strong long-term assets, positive investment performance, and intentional planning to strengthen sustainability. The work now underway to expand building use, explore partnerships, and align expenses with recurring income positions the church to move forward with confidence. With faithful support, prudent management, and a clear focus on mission, Westminster remains well-equipped to sustain and grow its ministries in the years ahead.

In 2023, the Finance Team of Westminster Presbyterian Church discontinued its relationship with an outside accounting firm to handle the church's finances. In September 2023, an in-house bookkeeper was hired. Both 2024 and 2025 continued to be years of transition as we carefully reviewed, strengthened, and refined our financial processes and reporting methods.

As a result of these operational changes, formal audits for the years 2022 through 2025 have not yet been completed. Although a formal audit program has not been finalized, all receipts and distributions continue to be closely reviewed as part of the preparation of the monthly financial statements to ensure accuracy, transparency, and proper stewardship of church resources.

During 2026, we will focus on bringing the outstanding audits up to date.
